Socio-economic characteristics of NPS subscribers (all citizen model)

Summary

- ❖ Average subscriber enrolments in a year stood at 2.89 lakh in the absolute terms, comprising of 24% female subscribers and 76% male subscribers during the last 05 years.
- As per *age group analysis*, majority of the enrolments were from the age group of 26-35 years (33%) and 36-45 years (31%) during the last 05 years.
- ❖ As per *educational qualification analysis*, 81% of the subscribers enrolled during the last 05 years were graduates (47%) and post-graduates (34%).
- ❖ As per *occupation analysis*, enrolments from private sector were highest (54%) during the last 05 years.
- ❖ As per *income analysis*, 2/3rd of the enrolments were from the income group of Rs 5-25lakh (36%) and Rs 10-25 lakh (30%) during the last 05 years.
- ❖ As per *location analysis*, enrolments from the state of Maharashtra were the highest at 17% of total enrolments during the last 05 years.

This paper analyses the social-economic characteristics of voluntary subscribers enrolled in NPS during the last 05 years *i.e FY 2016-17 to FY 2020-21*. The National Pension System (All Citizen Model) was introduced in May 2009 for voluntary subscription by any citizens of India (resident/NRI/OCI), aged between 18 to 70 years (at the time of subscription).

NPS is a low cost, tax-efficient retirement plan wherein a subscriber contributes towards accumulation of a retirement corpus during his/her working life to procure a pension upon retirement from work. The objective of this scheme is to provide old age income security to the subscribers.

Methodology and data set

The analysis of subscribers is based on secondary data and study of 14.45 lakh individuals who had joined the NPS All Citizen Model during the financial year 2016-17 to 2020-21 (from 1st April to 31st March).

The analysis of subscribers is organized into seven sections; **Section-1**, Gender Analysis. **Section-2**, Age group Analysis. **Section-3**, Educational Qualification Analysis. **Section-4**, Occupation Analysis. **Section-5**, Income range Analysis. **Section-6**, Location Analysis. **Sector-7**, Freeze Account Analysis.

Section - 1: Gender Analysis



Out of the total 14.45 lakh subscribers enrolled during the last 05 years,

24% were female, 76% were male and 0.001% were transgender subscribers.

- During the last 05 years, female subscriber enrolments in percentage terms were range bound between 22.9%-24.9% (*Table -1 & Figure-1*)
- In FY 2020-21, male subscriber enrollments were highest at 3.18 lakh in absolute terms but were lowest in percentage terms (75%). (*Table -1 & Figure-1*)
- Total subscriber enrolments exhibited positive growth y-o-y except for FY 2018-19. (*Table -1 & Figure-1*)





Out of the total 14.45 lakh subscribers enrolled during the last 05 years, majority of subscribers were from the age group of 26-35 years (33%), 36-45 years (31%) and 46-55 years (21%).



- During the last 05 years, enrolments of subscribers aged 18-25 years and 26-35 years exhibited positive trends. (*Table-2 & Figure-2*)
- Enrolment of subscribers aged 56-60 years exhibited negative trend. (*Table-2 & Figure-2*)
- Enrolment of subscribers aged 46-55 years declined in percentage terms. (*Figure-2*)





Out of the total 14.45 lakh subscribers enrolled during the last 05 years, majority of subscribers were graduate (47%) and post-graduate (34%)



- During the last 05 years, enrolment of graduate individuals exhibited positive trend in percentage terms. (*Figure-3*)
- Percentage of subscribers with SSC qualifications enrolled during the last 04 years remained unchanged at 3% (*Figure-3*)
- In percentage terms, enrolments of professionals were on a declining trend. (*Figure-3*)





Out of the total 14.45 lakh subscribers enrolled during the last 05 years, majority of subscribers were from private sector (54%) and Govt./PSU (26%)



- During the last 05 years, enrolments from private sector remained range bound between 53%-55% in percentage terms but increased in absolute terms. (*Table-4 & Figure-4*)
- Enrolments from Government/PSU sector declined in percentage terms. (Figure-4)
- Enrolments of self-employed individuals exhibited positive trend. (*Table-4 & Figure-4*)
- Students and agricultural subscribers had exhibited nominal growth in absolute terms but in percentage terms remained unchanged at 1%. (*Table-4 & Figure-4*)





Out of the total 14.45 lakh subscribers enrolled during the last 05 years, majority of subscribers were from the income range 5-10 lakh (36%) and 10-25 lakh (30%)



- Enrolment of individuals having annual income upto 1 lakh declined in percentage terms since FY 2017-18. (*Figure-5*)
- Enrolments of individuals having annual income of more than 25 lakh remained range bound between 5%-6% in percentage terms. (*Figure-5*)
- 86%-91% of subscribers enrolled were from the income range of 1 lakh to 25 lakhs. (*Table-5 & Figure-5*)





Out of the total 14.45 lakh subscribers enrolled during the last 05 years, 32.6% were from West zone, 25.8% from North zone, 22.8% from South Zone and 18.2% from East zone



- During the last 05 years, the state of Maharashtra accounted for highest subscriber enrolments in absolute and percentage terms. (*Table-6 & Figure-6*)
- Subscriber enrolment from the state of Gujarat and West Bengal remained range bound between 6%-8% (*Figure-6*)
- Subscribers enrolments from the state of Karnataka, Gujarat and Haryana depicted y-o-y growth in absolute terms. (*Table-6*)



Section-7 Freeze account analysis

Freeze account: These are accounts inactivated in the CRA system due to various reasons viz. requirement of photograph, signature, KYC verification pending by PoP, non-contribution of Rs 1000 in a year, duplicate, non-submission of forms to CRA, etc.

- Average 11% of the total accounts opened got frozen during the last 05 years.
- For the last 02 financial years 2019-20 & 2020-21, the percentage of frozen accounts vis a vis new account opened was only 3% & 5% respectively.
- The gender proportions of frozen accounts were similar to enrolments i.e. 3/4th male and 1/4th female subscribers.
